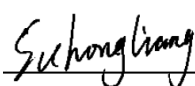

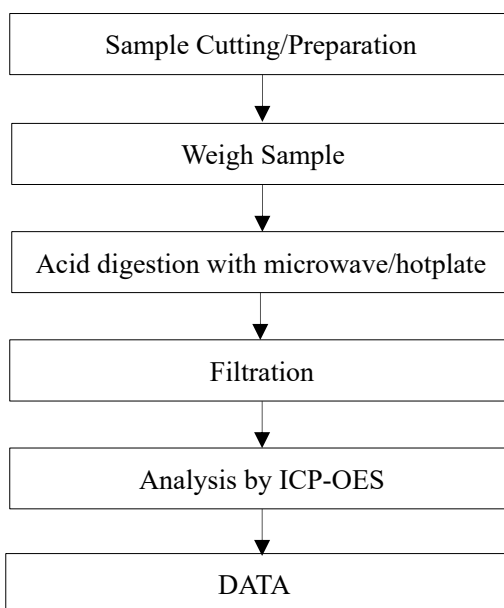

Test Flow Chart of Heavy Metal Content



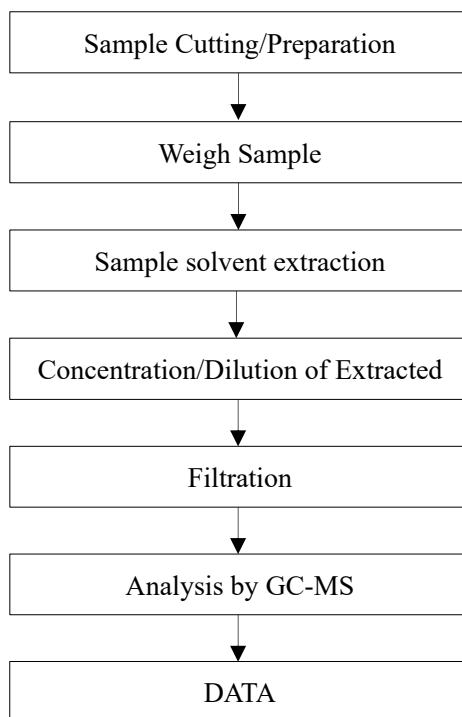

Test Flow Chart of Phthalates



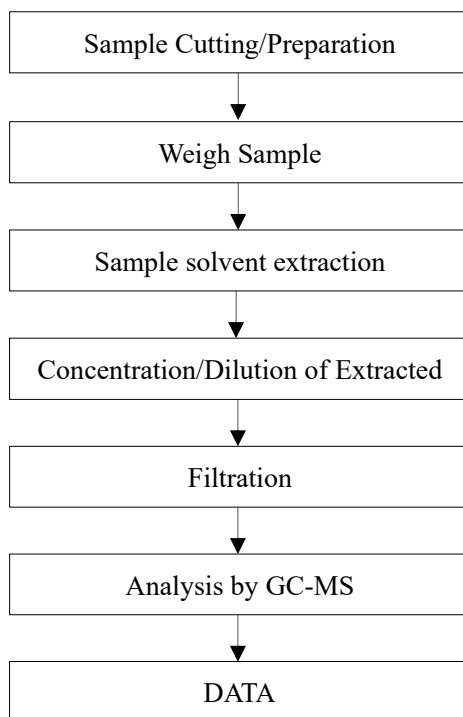

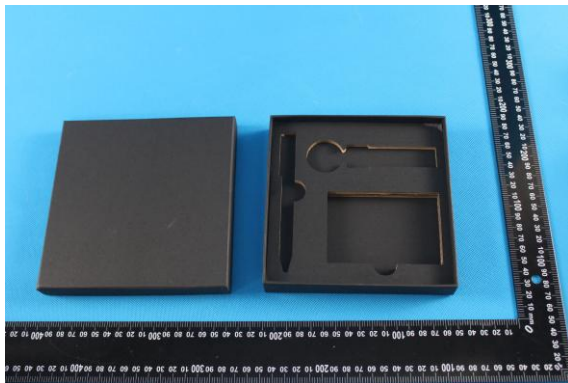

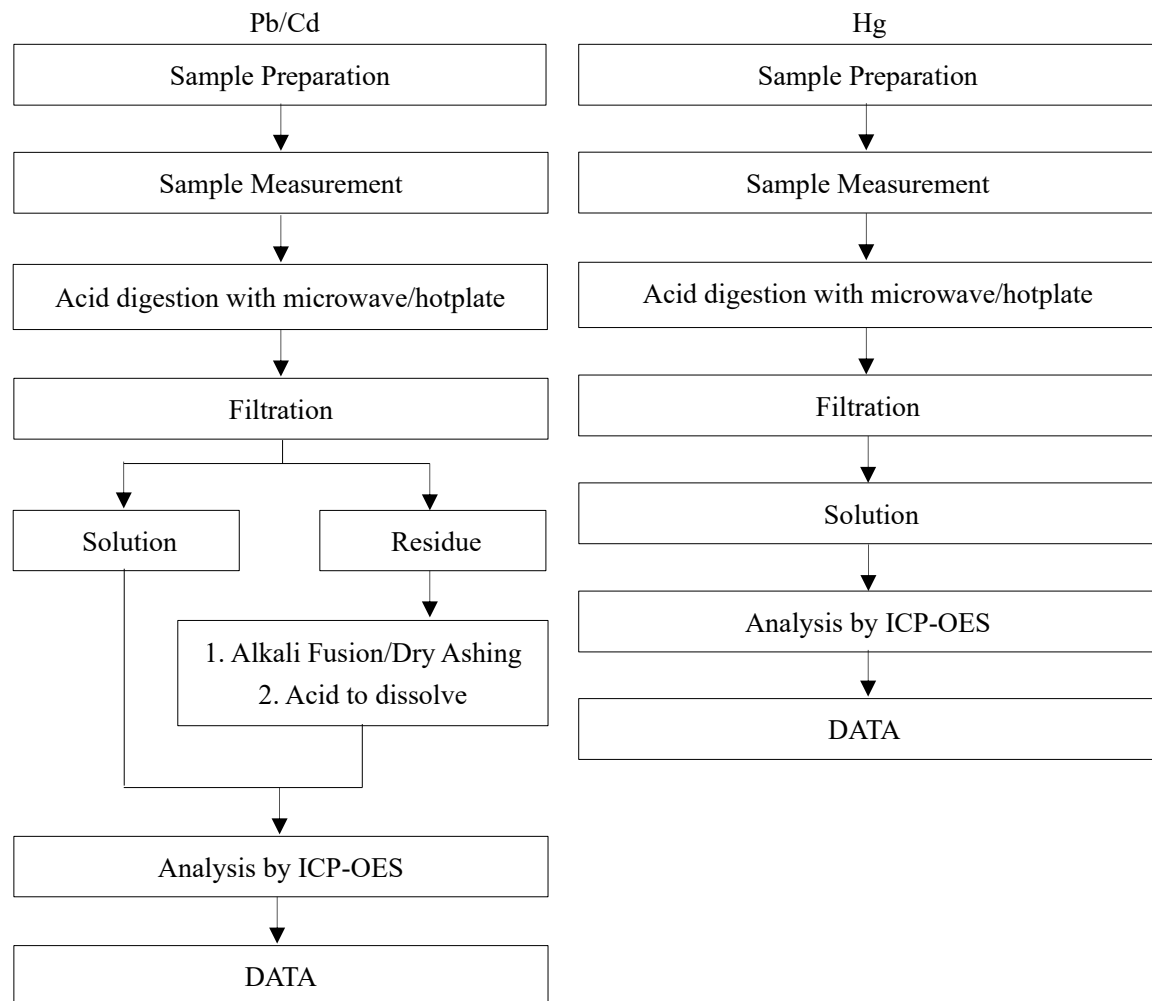

Test Flow Chart of Lead, Cadmium and Mercury



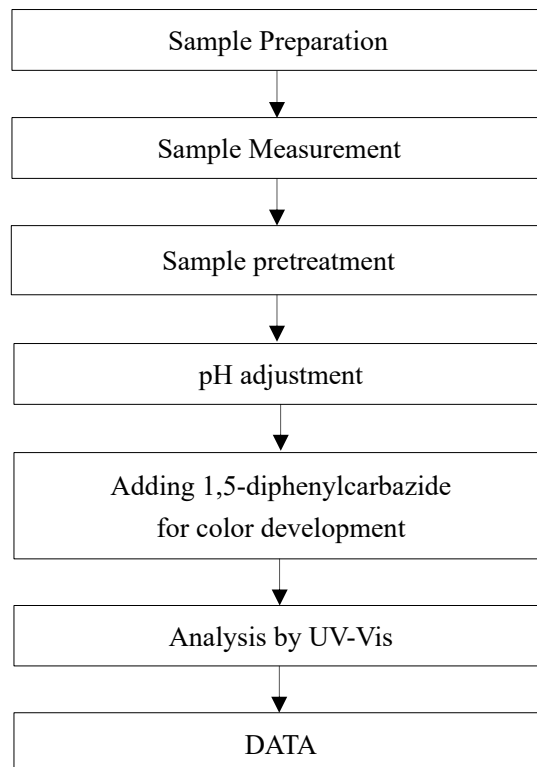
