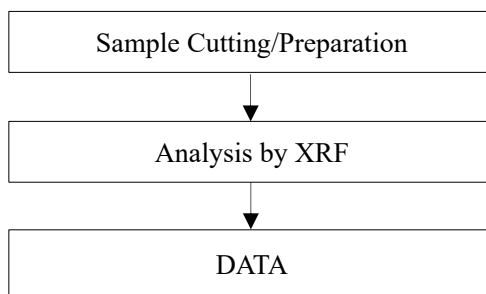

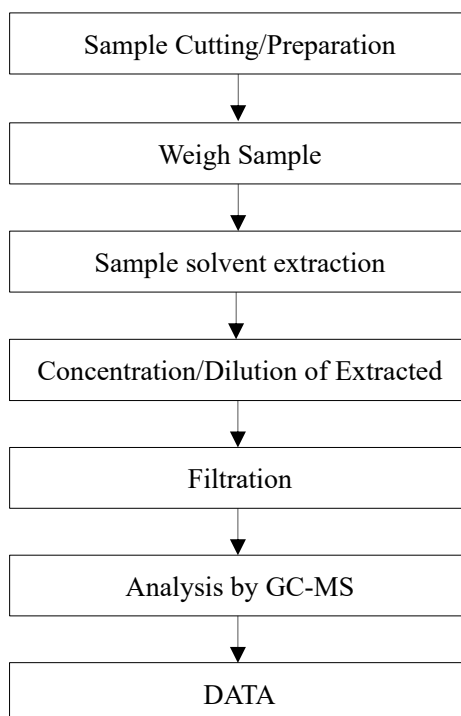

### Test Flow Chart of Phthalates



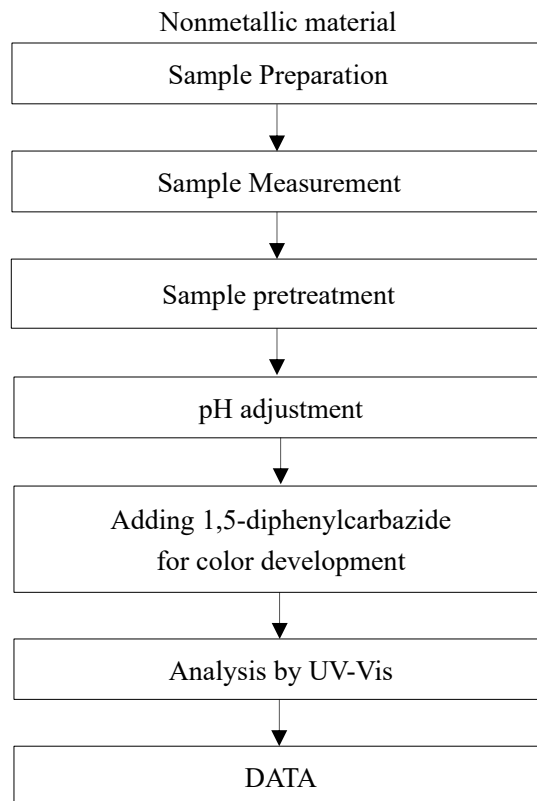

### Test Flow Chart of Hexavalent Chromium ( $\text{Cr}^{6+}$ )

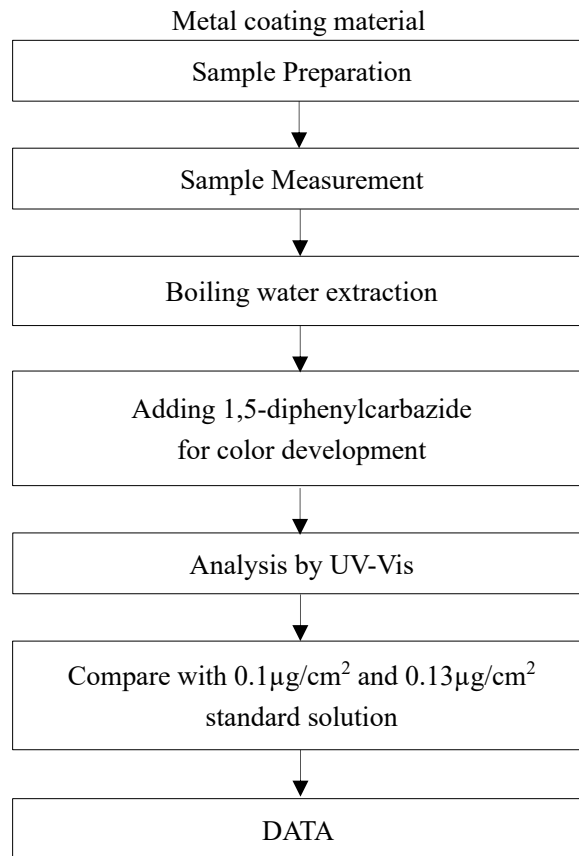

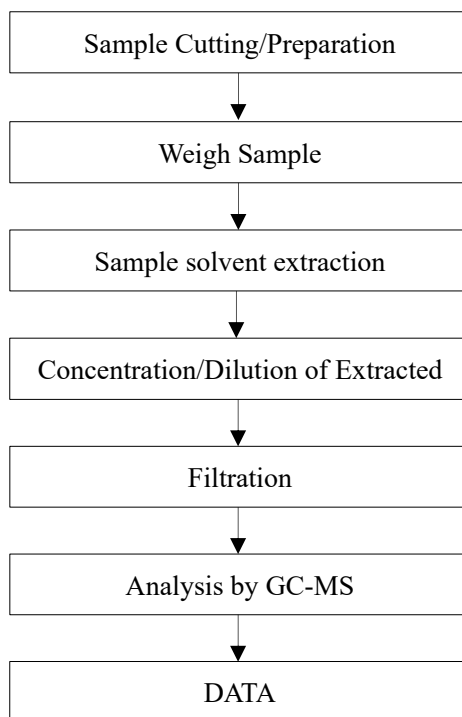
