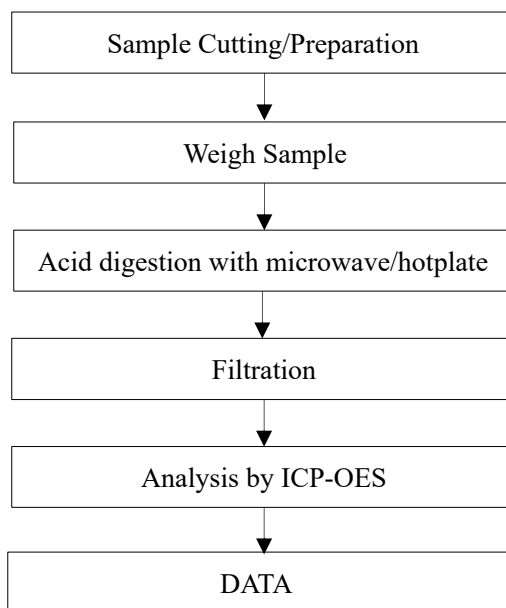

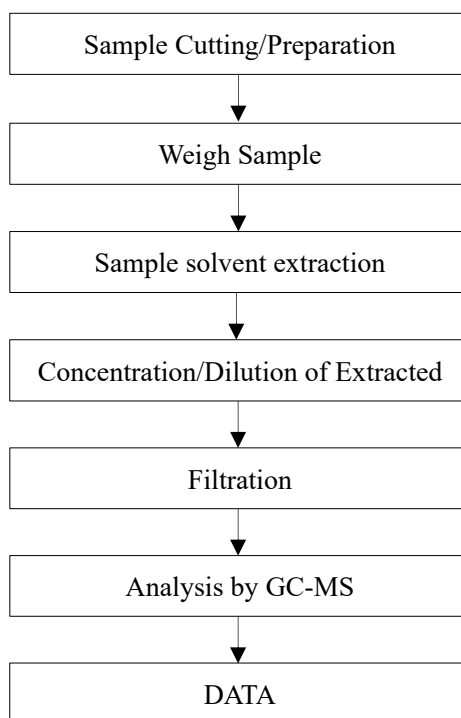

Test Flow Chart of Phthalates



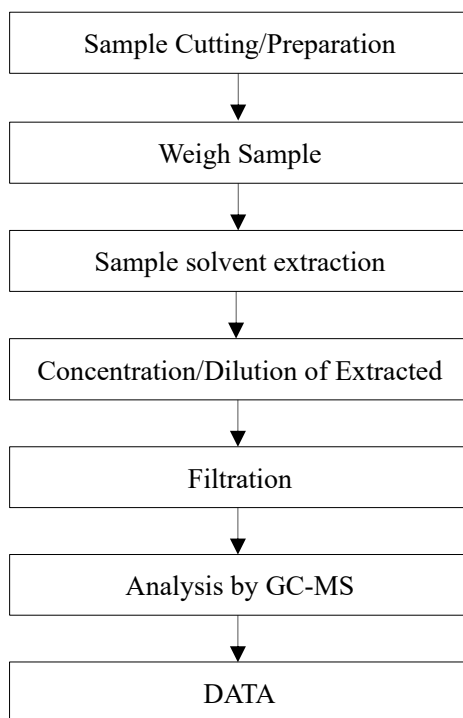

Test Flow Chart of Polycyclic-aromatic Hydrocarbons (PAHs)



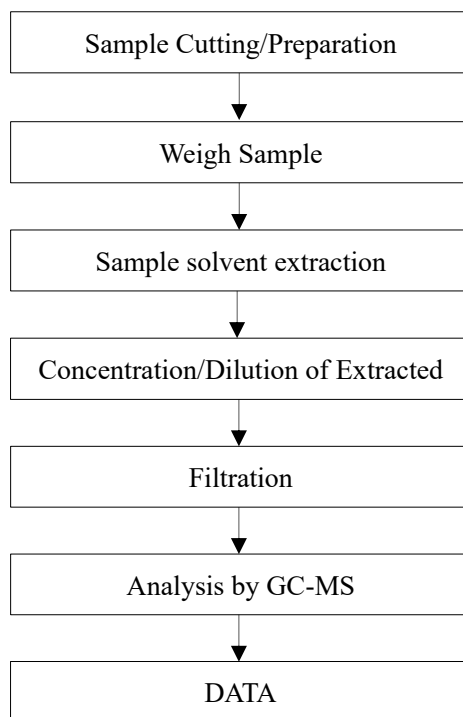

Test Flow Chart of Pentachlorophenol (PCP)



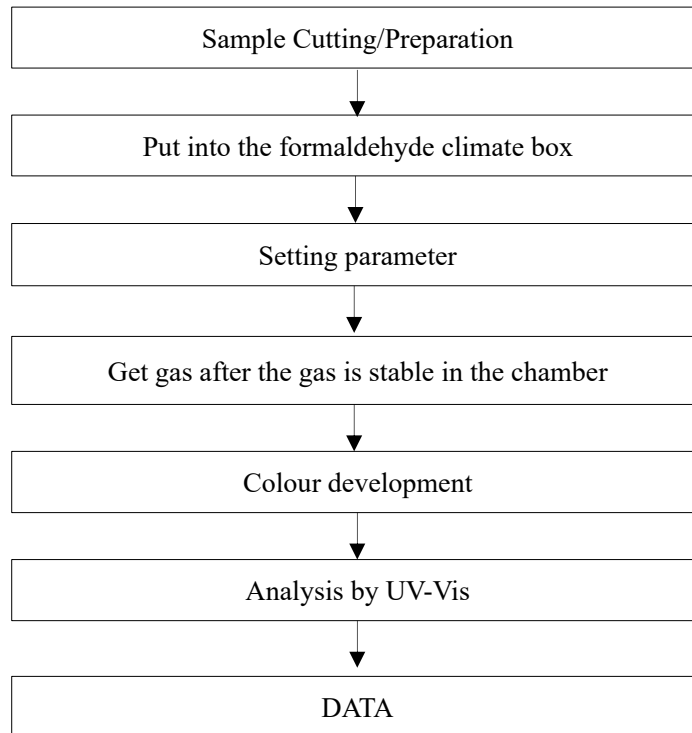

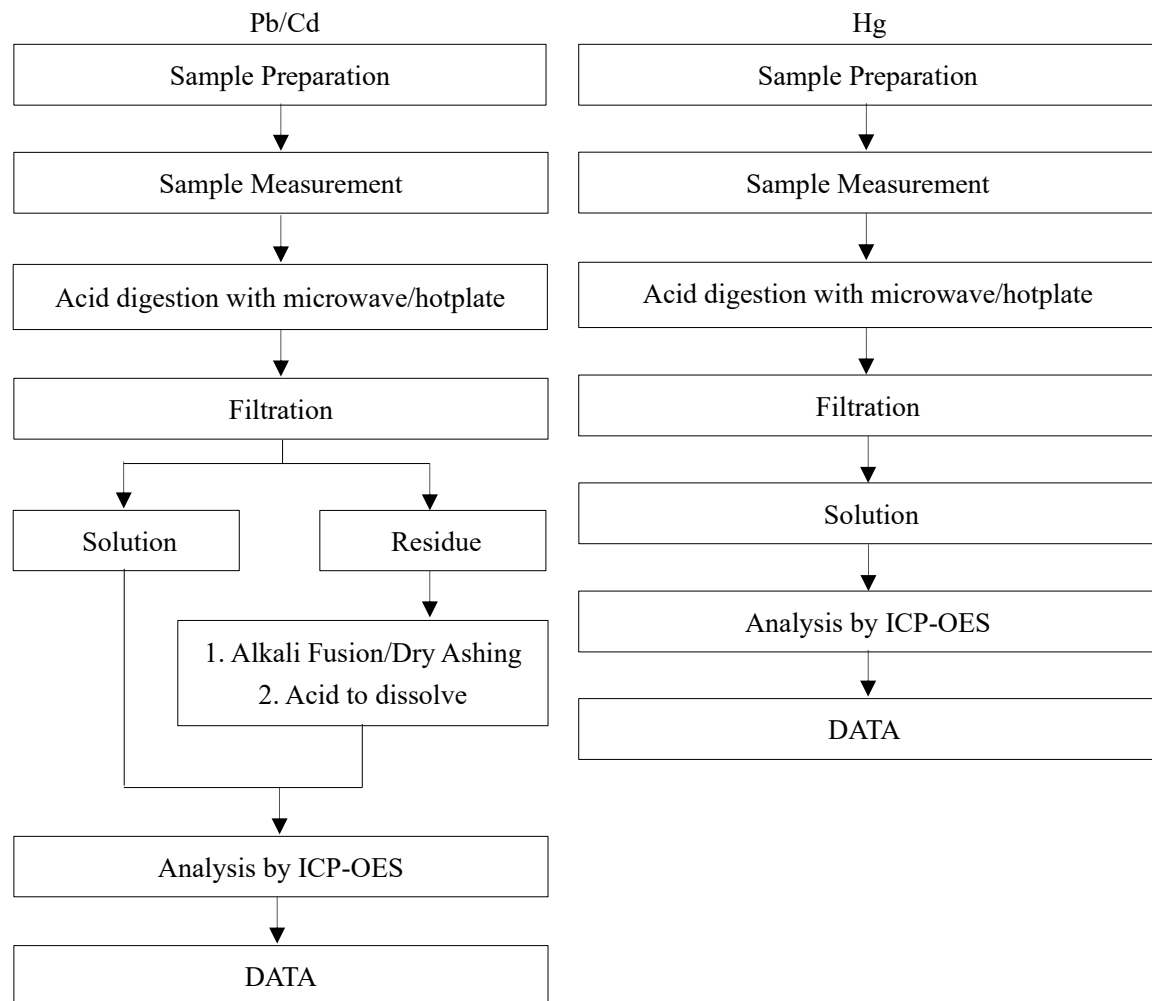

Test Flow Chart of Lead, Cadmium and Mercury

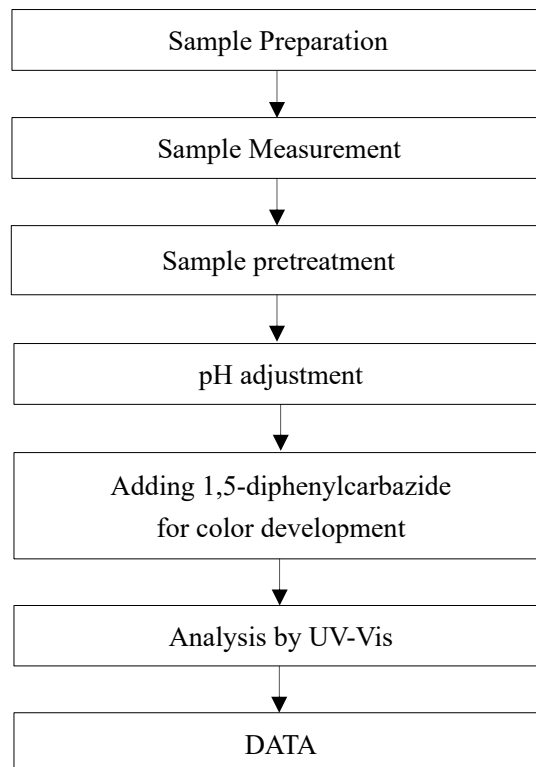
